### **Community Involvement**

The organization provides for those in need of assistance for rent, utilities, house payments, medical needs, food, funeral expenses, and clothing.

The agency's clients are Oldham County residents who are living paycheck to paycheck and have an extraordinary event happen which they cannot afford. They are residents who are working but do not have medical benefits and need medicine or doctor/dental assistance. They are people who are recently unemployed or newly separated from their spouse and do not have income or unemployment benefits to cover their expenses. They are grandparents taking care of grandchildren on their fixed incomes. They are handicapped individuals needing assistance not covered under other government programs or are waiting for approval for government programs that will help later.

This agency helps cover the needs of family living but does not stop there. Our Executive Director counsels all clients to help better themselves for the extended future and not just an immediate fix of funds. Counseling involves job placement recommendations, right sizing their living arrangements, and direction assistance to government programs for health and welfare programs.

# Established July 20, 1945

During the closing months of World War II a group of concerned citizens within Oldham County, members of the "Post War Planning Committee", focused on the needs of the county. They discussed improving telephone service, improving medical services, and studying rural electrification. One important topic was the establishment of an organization called Community Chest of Oldham County.

INITIAL PURPOSE: "It was decided to advise the post war planning committee that a Community Chest be formed for reasons of meeting the medical needs of the indigent and other needs that might arise."



### **Community Involvement**





From the inception, Community Chest of Oldham County was the product of community involvement. In the early spring of 1945 a group of concerned citizens, members of the Post War Planning Committee, created the Community Service Committee.

This sub-committee's purpose was to focus on six challenges: rural electricification, improved telephone service, sewage, improved roads, adequate health, and community chest. This sub-committee quickly formed the Community Chest of Oldham Co. Articles of incorporation were signed, directors elected, and 21 individuals in the community were asked to serve as members of the Community Chest. The members began the campaign process to collect money from the community through various fund drives.

**1940's: On July 20, 1945**, decade the agency was created and nurtured by members of the community. Public fund raising drives were started by the agency and funds were distributed.

**1950's:** During this decade the agency continued the public fund raising activities so they could promote and co-ordinate the work of associations for civic, educational and philanthropic purposes.

**1960's:** During this decade the agency decreased public fund raising activities. The organization activities became more closely associated with the requests of the County Judge's office.

**1970's & 1980's:** The agency was ran from the County Judge's office. The agency evolved more into the sole purpose of emergency assistance.

Oldham County 1990's & 2000's: The agency continued to focus on emergency assistance. It was removed from County Judge/Executive's office in the early 1990's. The agency began working with funding sources like Metro United Way, The Mahan Foundation, Mallory Taylor Foundation, Peyton Samuel Head Family Trust and others. This funding helps provide the daily assistance given.

### **Helping Local Residents**

Community Chest of Oldham County has existed for almost eight decades to do primarily one thing: Provide emergency assistance to individuals and families in the county.

For three decades (right at 30 years), Elizabeth "Maria" Moore was the Executive Director, providing the day-to-day leadership of the agency. In 2024, she retired from this position due to health reasons.

Her husband, Timothy Moore, was very involved behind the scenes for those same years and was approved by the board to replace Elizabeth at their March 2024 meeting.

#### A Sense of History

Understanding how Community Chest of Oldham county began and the mission the agency has carried on through the decades. CCOC was built upon the shoulders of those which came before us to help residents in the county with emergency needs. Many times, helping those in need requires a listening ear and leaning on relationships with other agencies in the county.

#### Compassion

Active involvement with Community Chest requires compassion and empathy for those in need. Having an understanding that others might not have all the benefits of growing up in and experiencing a "normal life" (whatever this term may mean to you) which places them in situations you would not ever find yourself... again requires compassion on the part of CCOC associates and board members.


#### **Financial Management**

Community Chest is an agency which distributes close to \$90,000 each year in funds donated by others. Keeping orderly books, safeguarding checks and gift cards, and reconciling book balances to outside entities is a must skill to possess for those charged with the safekeeping of agency assets and reports.

#### More than "Yes or No"

Community Chest interacts with many individuals and families over the course of each year. Most every time the request for help cannot be answered with a simple yes or no. The story leading up to the request should be heard. Questions diving deeper into the situation must be asked. Time needs to be spent with each client request because many times, the help we provide goes way beyond a simple check being written to a landlord or utility company.


### **Client Processing**



Whether clients receive a payment to landlords or vendors, they also receive counseling to find a primary job or additional part-time or second jobs to help place them on a better long-term financial footing. The Executive Director is always on the look out for job openings around the community. The agency also makes recommendations for less expensive rental locations/apartments.

We also recommend they take budgeting/finance classes when the cases warrant this advice.



### **Trailing Ten Years Client Assistance**



Assisted One Time During Calendar year


